




To The Dungeon!

Thirteen offences required solitary confinement on bread and water.


Out of Sight:

 Off the road and seldom visited, conditions were ripe for abuse.

"The dungeon of Portsmouth has scarcely been heard of beyond the boundaries of that town, and yet its victims suffer none the less.



The bread and water of the captive in the Bastile was probably sweet as that given to the feeble old woman or the broken spirited old man in the dungeon of Portsmouth . . . "

From The Top:


 Outvoted at town meetings, concerned residents unable to break the cycle of oppression at the Asylum.

Bragging Rights:

• Former commissioner of the poor, boasting of flogging the insane, receives approbation rather than disgust of majority. "A significant glance by the keeper to the rebellious pauper and thence



towards the dark hole, would convey a hint sufficient to prevent any exposures." T. R. Hazard 1851

• T. R. Hazard "insisting upon the correctness of his report . . . and offering to prove the facts therein stated."

"It seems that there is one town, at least, in the state, who, in virtue of authority delegated by you to them to provide for the care of their own poor, have decided poverty to be a crime of so deep a dye, that anyone found guilty of the offense within its jurisdiction, shall no longer be deemed worthy to partake of the inestimable privileges of an American citizen."
